2023 Local Government Workshop

The Local Tax Allocation Division (LTAD) hosted their annual local government workshop on June 14, 2023. Topics discussed included a detailed description of the various tax types, the timing of disbursements, and instructions for completing the monthly tax location verification (TLV) process. Fiscal Year 2024 Personal Property Replacement Tax (PPRT) Estimate

The PPRT estimate for FY2024 will be posted in early August and made available on our [Most Frequently Used Links webpage](#). Once posted, we will send notification via both MyLocalTax and IDOR News & Updates, our email/SMS text subscription service.

Grocery Tax Suspension

The one-year suspension of the state one-percent (1%) low rate of sales and use tax on retail sales of groceries normally taxed at this rate ended on June 30, 2023. While local governments should not have been impacted by that suspension, retailers should resume collection of the one-percent (1%) low rate tax on sales of groceries effective July 1, 2023.
